Schedule for Graduate School of Global Governance Degree Requirement for Ph.D. Program

(*1) Conditions for Public Hearing

- The applicant must have a session with examiners to obtain their agreement to go to Public Hearing.
- Faculty Committee formally approves Public Hearing based on the examiners' judgement.

(*2) Preliminary evaluation (Public Hearing)

: Members of Faculty Committee, students, outside researchers will be invited to join

- Judging whether the candidate is eligible to apply for the degree.
- Public Hearing and examiners' assessment should be done as soon as possible after Faculty Committee formally approves Public Hearing.
- The Q/A session will be based on the subject of the examination.
- Candidates will be asked to rewrite the dissertation according to comments which were raised at the Public Hearing.

(*3) Oral defense

: Only nominated examining members will participate

- Final screening of the dissertation.
- It should be held as soon as possible after Faculty Committee formally accepts the submission of dissertation (2nd time).
- Candidates will be asked to rewrite the dissertation based on the screening result.
