(*1) Mid-Term Presentation

- Students shall conduct Mid-Term Presentation before applying for Public Hearing. Faculty members and students of GSGG are allowed to participate in the presentation.
- The supervisor determines if his/her student(s) can apply for Public Hearing or not, following the result of the presentation.

(*2) Conditions for Public Hearing

- The applicant must have a session with examiners to obtain their agreement to go to Public Hearing.
- Faculty Committee formally approves Public Hearing based on the examiners' judgement.

(*3) Preliminary evaluation (Public Hearing)

- : Members of Faculty Committee, students, outside researchers will be invited to join
- Judging whether the candidate is eligible to apply for the degree.
- Public Hearing and examiners' assessment should be done as soon as possible after Faculty Committee formally approves Public Hearing.
- The Q/A session will be based on the subject of the examination.
- Candidates will be asked to rewrite the dissertation according to comments which were raised at the Public Hearing.

(*4) Oral defense

- : Only nominated examining members will participate
- Final screening of the dissertation.
- It should be held as soon as possible after Faculty Committee formally accepts the submission of dissertation (2nd time).
- Candidates will be asked to rewrite the dissertation based on the screening result.
