

Application Guidelines for the Meiji University Scholarship for Privately Financed International Students 【Fall Selection in AY 2025】

1. Eligibility (Those who meet the conditions of A and B below)

A Privately-funded international students enrolled in one of the following degree courses. (Excluding those who enrolled in September 2025 or who are waived from tuition fee such as exchange students)

- (a) Students enrolled in the second year or above at undergraduate level.
- (b) Students enrolled in master's or professional degree programs in the graduate school.
- (c) Students enrolled in doctoral degree programs in the graduate school.

B Other requirements (All of the following must be fulfilled)

- (1) Students with high motivation, outstanding academic results but who have difficulties in attending school for financial reasons
- (2) Students who have valid "Student" residence status as of October 10th, 2025.
*If you do not have valid "Student" residence status as of October 10th, 2025, you must meet one of the following requirements;
 - (a) Students who have applied for COE at the International Student Office by 17:00 on October 10th, 2025.
 - (b) Students who have taken the necessary procedures related to gaining "Student" resident status at the International Student Office by 17:00 on October 10th. (E.g., Renewing validity period, Changing resident status).
 - *Students who don't have "Student" residence status due to having participated in study abroad programs organized/approved by Meiji University are eligible.
- (3) Students who attain scores for their latest cumulative GPA as set out below;
 - Undergraduates: **2.00** or above
 - Graduate students: **3.00** or above
(1.70 or above: only for the Graduate School of Professional Accountancy)
- (4) Students who earned the necessary number of credits below. (Undergraduate students ONLY)

Necessary number of credits: number of semesters enrolled × 15 credits
- (5) Students who haven't repeated the same grade in AY 2025 and who didn't take/will NOT be taking a leave of absence in AY 2025.
*Note: Students repeating the same grade caused by a leave of absence in the previous academic year may be eligible. Please consult with the International Student Office in advance in that case.
- (6) Students who are not subject to disciplinary action in AY 2025
*Those who were the subject of disciplinary actions such as removal from the school register, expulsion, withdrawal, etc. after applying will not be eligible for selection.
*Once you have been removed from the school register in the year when you applied, even if your removal is canceled, you will not be eligible for selection in that year.
- (7) 【For scholars of the Meiji University Scholarship for Privately Financed International Students in AY 2024】
Students who submitted a report by the designated deadline.
- (8) Students who don't receive a stipend more than 25,000JPY per month from other scholarships in AY 2025.
*Note 1 : Those receiving "MONBUKAGAKUSHO Honors Scholarship" are NOT eligible.
*Note 2: Those receiving "Meiji University Special Grant for Privately Financed International Students" are eligible for this Scholarship.
- (9) Students who are **NOT scholars of the "研究奨励助成金" ("Graduate School Research Scholarship" etc.)** (including previous years)
- (10) Students who are NOT scholars of the "Meiji University International Students Incentive Scholarship Program"

3. Overview of the scholarship

Stipend	50,000 JPY / month
Payment period	Six months (October 2025 to March 2026)
Payment method	Transferred to the recipient's bank account * Lump-sum transfer of six months' worth of payments is scheduled in late January 2026. *The bank account must be with a bank in Japan and in the student's name.
Number of scholars	159 in total

Cancellation of Scholarship	<p>The decision to award the scholarship may be cancelled or the award may be suspended and the scholarship may be returned if any of the following apply</p> <p>(1) When the recipient's student resident status changes to another status</p> <p>* Recipients will be required to re-present their residence card after being selected.</p> <p>(2) When the recipient takes a leave of absence or leaves the university.</p> <p>(3) When false declarations are found.</p> <p>(4) When the recipient is deemed to be an inappropriate recipient for the scholarship award for any reason.</p> <p>(5) When the recipient is punished by the university.</p>
Obligations	<p>All recipients are required to submit a "Study Report (designated form)" during the designated period. Those who fail to submit it by the designated deadline will lose eligibility to apply for this scholarship for the next academic year. (The details will be announced later.)</p>

4. Screening

Criteria for selection	Based on the applicant's academic record up to the Spring Semester AY 2025.
Announcement of Results	<p>All applicants will be informed of their results through Oh-o! Meiji system in the middle of November.</p> <p>*Recipients are required to submit their bank account information and a pledge. The details will be announced later.</p>

5. Handling of Personal Information

Meiji University will use any submitted personal information only for the purpose of scholarship related matters, including screening, the decision-making process, and related office work. This is in compliance with the Meiji University Educational Foundation Personal Information Protection Policy and the Personal Information Protection Law and Regulations. Personal information will only be provided to a third party in compliance with laws and regulations, and never be used for other purposes.

6. Notes

- (1) Any applicants who are found to be ineligible after completing the application procedure will be disqualified from the screening.
- (2) Meiji University will contact students via the Oh-o! Meiji system. Please make sure to check it frequently.
- (3) No inquiries about the selection results are accepted.
